# With your liaison, plan your November 6-10 lobby meeting(s)

Summary: Work together to plan your meeting(s) with Congress the week of November 6-10 by, (1) attending CCL's live lobby trainings, (2) using CCL's meeting template to make a strategic plan for your lobby meeting(s), and (3) assembling and rehearsing your dream lobby team. *Read on for the details.* ↓



### Get trained and create a plan for your November lobby meeting(s)

#### **Attend lobby trainings**

Everyone — and especially lobby team members — should plan to attend our <u>October 23 Primary and Supporting Asks training</u> and our <u>October 26 Legislative Plan training</u>, led by CCL's D.C. team. First time lobbyists must complete CCL's Climate Advocate Training before lobbying and can do so by viewing a <u>recording</u> of the training on CCL Community or attending our <u>Nov. 5th Conference CAT Workshop</u>.

You can find foundational lobby trainings, policy explainers and other helpful resources on CCL Community's <u>Preparing for CCL's Fall Conference and Lobby Days</u> (cclusa.org/preparing-for-lobby-day).

### Make a strategic plan for your lobby meeting(s)

Ask an experienced liaison in your chapter to share CCL's respectful approach to lobby meetings and how we work to form meaningful relationships with the offices of our MOCs, while building political will for more climate legislation. Then use our <a href="Meeting Plan Template">Meeting Plan Template</a> (cclusa.org/meeting-plan-template) as a guide to solicit, discuss and prioritize everyone's ideas for the lobby meeting. Also use CCL Community's <a href="Meeting To">Getting To</a> <a href="Meeting To">Know Your Member of Congress</a> training to update your <a href="MOC's bio">MOC's bio</a> (cclusa.org/bios).

#### Assemble your dream lobby team

Brainstorm with your meeting attendees to see if you can add the following folks to your lobby team:

- 1. A CCLer who has been impacted by climate change.
- 2. A new recruit so they can be empowered by the lobby experience.
- 3. A trusted messenger who can make a persuasive case for more climate legislation. For details, see CCL Community's <u>Bringing Grasstops Leaders to Lobby Meetings</u> training.

Once you have a short list, determine who will contact these potential lobby team members. Then be sure to rehearse and role-play the lobby meeting in advance!

#### Organize your watch party

Watch parties provide a welcoming in-person space that helps everyone connect and deepen engagement, especially for new volunteers. Designate a few people to plan a watch party for November 4th at 10 a.m. PT / 1 p.m. ET so your chapter can participate in our Fall Virtual Conference together as a group. Be sure to include time for socializing, food and Q&A. Join an hour early for CCL's biggest ever Info Session at 9 a.m. PT/ 12 p.m. ET. See CCL Community's Watch Party Toolkit (cclusa.org/party-toolkit) for help with planning. If November 4th is not a good date for your event, organize a watch party afterward to view a Conference session recording (cclusa.org/presentations).

### Invite people to your watch party

Work together to, (1) share widely this opportunity to learn fresh advocacy ideas and tips for how to engage community members and members of Congress, and, (2) use the social media graphics and flyers from our <u>Fall Conference Outreach Toolkit</u> (cclusa.org/fallconfoutreach) in your October outreach and when you personally invite people. Invitees could include:

- Members of other organizations like League of Women Voters, faith groups, and environmental clubs

# Educate and activate your district on the Energy Innovation Act GRASSROOTS AND LOBBYING ACTION | Carbon Pricing •

The Energy Innovation and Carbon Dividend Act (H.R.5744) has been reintroduced. It's time for action!

The first step is to ensure everyone in your chapter, plus friends and family, write to urge House Reps to cosponsor the bill (use **cclusa.org/energy**). Next, make a grassroots plan to build support for the bill in your community. We want every representative to see loads of support for this bill in their district.

#### Schedule some tabling events and print our updated Constituent Letter Form and other materials

Plan one or more tabling events, sign up volunteers in shifts to staff the table(s) and download our <u>updated</u> <u>Energy Innovation Act tabling materials</u> (cclusa.org/energy-innovation-act-tabling).

Our paper Energy Innovation Act Constituent Letter Form is back and you can <u>download it here</u> (cclusa.org/constituent-letter). For other tabling materials, you might print only one or two copies and then invite table visitors to scan the QR code to get more information. If weather hinders outside tabling, find an indoor venue where you can educate, activate and recruit people.

#### Download our updated slides and send presentation proposals to local organizations

Identify someone in your chapter who enjoys public speaking and ask them to download our updated <u>Energy Innovation Act slides</u> (**cclusa.org/energy-innovation-act-slides**) and give a practice presentation for your chapter.

# Practice explaining the benefits of the Energy Innovation Act

The reintroduced Energy Innovation and Carbon Dividend Act is critical to meeting the U.S.'s emissions reduction target. And since the passage of the Inflation Reduction Act and other climate provisions in 2022 has impacted how we talk about it, here are some updated bill benefits that you can practice before getting active in your community.

### Suggestions for how to practice

We know that people learn best by saying the words out loud themselves, so for this exercise:

- Read these instructions to meeting attendees:
   <u>Instructions</u>: With a partner, take turns reading aloud our fresh **Energy Innovation Act benefits** below.
   Afterward, discuss the points that you remember. You'll have six minutes.
- 2. Ask two people to model the exercise, and then invite everyone to practice.

<u>If you use Zoom breakout rooms</u> (see <u>Zoom's training page on "Breakout Rooms"</u> to learn how): Put everyone into breakout rooms, two people per room, for six minutes. When everyone comes back together, ask a few people to share some highlights from the exercise.

If you use Zoom, but don't use breakout rooms: invite a few attendee pairs to follow the instructions.

#### **Benefits - Energy Innovation Act**

<u>Net Zero by 2050</u>. This policy will deploy the single most powerful tool we have to drive down America's carbon pollution and ensure a healthy climate. It is critical to hitting our climate targets of 50% carbon pollution reductions by 2030 and net zero by 2050.

<u>Affordable Clean Energy</u>. Americans shouldn't have to live with the price shocks and rising energy prices associated with fossil fuels. This policy will drive energy innovation, giving every American community access to abundant, affordable clean energy produced right here at home.

<u>Puts Money in Your Pocket</u>. The money collected from the corporate polluter fee goes directly into the pockets of millions of hard-working families via a monthly carbon cashback payment. The money can be spent without restrictions, and most low and middle income Americans will come out financially ahead or break even.

<u>Saves Lives</u>. This policy will help improve health and save millions of American lives over the next 50 years by reducing pollution Americans breathe. Poor air quality from burning fossil fuels is responsible for as many as 1 in 10 American deaths today, and sickens thousands more.
