I further grant permission to CCL/CCE to revise or edit any images and recordings of my minor child in a way that does not alter its basic message or intent, and waive any right to inspect the final content prior to its publication.

I hereby agree on my behalf, and on behalf of my minor child, to discharge and release CCL/CCE, fully and forever, from any claim for damages of any kind arising out of the use or publication by CCL/CCE of said images and recordings of my minor child. I further covenant and agree on my behalf, and on behalf of my minor child, not to sue or otherwise initiate legal proceedings against CCL/CCE for such use or publication of the recordings or images of my minor child. Additionally, I further represent on my behalf, and on behalf of my minor child that any statements made by my child are true, to the best of my knowledge, and certify that my child's appearance will not violate or infringe upon the rights of any third party, and hereby agree to indemnify and hold harmless CCL/CCE in the event of any third party claims resulting from a breach of the representations and warranties set forth herein.
