Reminder from Larry on Recertification:

Meeting attendance now earns more RUs per meeting. Below is a summary of changes to the 2018 RU Journal Guidelines:

- Based upon the new 2018 RU journal guidelines, meetings will now offer our members the opportunity to earn **.5 RU** per meeting. Also along the new guidelines a workshop will provide an additional **.5 RU** credit. In the past, the RU for both of these was .3 RU each.
- The Maximum RU credit allowed toward meeting and workshops is now **11.0 RU**. In the past the total allowed was 9.0 RU.
- Serving on Committees has been changed as well. Total allowed RU has been increased to **8 RUs** maximum instead of 6.0 RU.
- Proctoring for test has changed to maximum allowed to **7.0 RUs** over 3 years instead of 5 RU.
- A new category has been added, ASQ membership will allow **.5 RU** per year for a total of **1.5 RU** allowed over 3 years. There is no partial credit allowed, it must be one full year of membership to be eligible for the .5 RU yearly.

You can reschedule or cancel your exam at any time, as long as you do so more than five full calendar days before your scheduled exam appointment.
